Dignity Action Day



On 1st February we took part in the annual Dignity Action Day. Dignity Action Day aims to ensure people who use care services are treated as individuals and are given choice, control and a sense of purpose in their daily lives.



This year was the first time since the pandemic that we could invite everyone from around the Trust to come together and mark the occasion. It was clear that everyone who attended enjoyed catching up with friends, sharing a brew and of course cake! We were treated to a beautiful selection of cupcakes, kindly made by Louise Browns Bakes.

The day centered around the Trust's new values which were agreed upon at the end of 2022 after consultations with tenants and staff. These new values are at the very heart of everything we do at Rossendale.

The values are as follows;

Warm – The Trust is a homely environment where everyone feels welcome and well supported. (chosen by our tenants)

Respectful – We respect and appreciate others for their Individual beliefs, passions, goals, and choices whilst embracing person centred care. (chosen by our staff)

Inclusive – The Trust provides an inclusive environment where people of all backgrounds can come together and feel valued. (jointly chosen by staff and tenants)

During the day everyone was asked what these values meant to them and they were encouraged and supported to record their thoughts.

We then planted our own 'Digni-Tree' in the grounds of Rossendale Hall. Our values have been carved into logs which will surround the tree as a reminder to everyone who visits the Trust.

Zoe Williams, Family Liaison Officer at the Trust said "It was a wonderful afternoon and lovely to see so many tenants together again to celebrate a special day."



Welcome to Edendale



It is now time to replace "Harolds Cabin". We have used this cabin as an operational hub for a number of years.

It is a place for our day service users to meet before going out on trips and for the horticulture groups to make a brew and have their lunch. The cabin has served it's purpose but sadly is at the end of it's days. The roof leaks and the floor has gone in places. We are planning to replace it with a slightly larger insulated garden room. It will incorporate a separate but linked building as a **"changing places"** style toilet with a ceiling hoist.

We also plan to rejuvenate the area around and including the pond which has become overgrown with perennial weeds.

Once the remedial work has been completed by external contractors with a mechanical digger the pond area will be re planted according to a seasonal planting scheme as advised by Scotwood Nurseries, Swanscoe, Macclesfield.

There will be plenty of opportunities for volunteers throughout the year and we look forward to welcoming community involvement with this project which is now known as the Edendale project.

Happy Birthday WorkTaste & updates...

Way, way back in 2013 following a visit to Derwen College by our then Head of Care, and Family Liaison Officer, the idea of WorkTaste was born and the Rossendale Trust added a new department, WorkTaste.



It was set up to give our tenants a taste of the world of work. The project was only established after a successful fundraising campaign and the support of funders and donors remain critical to its success today.

The very first placement set up for Nick was at Broadstock Office Furniture. As a result of the structured approach and dedication of the whole team, Nick managed to maintain a full year of attendance! This placement was to continue for as long as Nick wished to attend, and his prized possessions were his clocking in cards and his uniform.

From that first placement, WorkTaste approached more and more local businesses to join them on their new quest, and as a result of some very supportive employers and fantastic collaborations WorkTaste has grown to where it is today.

We currently have 22 of our tenants in placements including Arighi Bianchi's, Moss Head Kennels, Bear Grills, The Gawsorth Hub to

name but a few. We even host our own placements at the Hall. We supply Job Coaches to local colleges where we support students on a 39 week Supported Internship program. We currently support 10 learners on a reduced support program which aims to lead them to paid work and we have 70% success rate! WorkTaste also support 5 external clients in a PA role and we encourage them to work as part of their support.

WorkTaste continues to grow and grow and we plan to provide even more support for people with physical and learning disabilities for many years to come.

Lisa Bracewell - **The Guild for Lifelong Learning**



Lisa started her WorkTaste placement at the Guild for Lifelong learning, based in Wilmslow, in October 2022 as an assistant in the community cafe. She was initially quite anxious and shy but she was made to feel welcome by the staff there. As she got used to her tasks and with the support of her WorkTaste coach and colleagues, we saw Lisa's confidence improve and she has really enjoyed her time at

work.

Following a meeting with WorkTaste and the Guild, we explored the possibility of some e learning to develop Lisa's skills and knowledge in the workplace. Lisa was enrolled onto the Essentials of Food Hygiene course, and we spent the next few weeks completing the modules. Lisa was fully engaged in the learning and concentrated well. She has good listening skills and was able to recall the answers to the questions from what she had learned in the sessions. Lisa achieved her certificate and her confidence increased even further.

After a couple of weeks putting her new skills and learning into practice, Lisa enrolled for the Level 1 Certificate in Food Hygiene. Again, Lisa listened well to the learning modules and was able to answer the test questions at the end. She achieved her Level 1 qualification and was really proud to receive her certificate.

The working partnership between WorkTaste and the Guild has proved that with the right support and encouragement our WorkTasters are enabled to achieve their work potential and develop their social and work life skills to great effect.

Congratulations to Lisa and thank you to the team at the Guild for their continuing support of our WorkTaste placements.

Helen Martin – Moss Head Kennels



Julie Barnes, WorkTaste Coach last worked at Moss Head Kennels in 1989. Back then, Manager Louise was on a YTS placement and Julie was her Placement Officer. So fast forward 34 years and Julie is now back there supporting Rossendale tenant, Helen on a WorkTaste placement.

Helen's placement is for one afternoon a week. She cleans out and sanitises the kennels and dog beds and gets them ready for the next canine occupant. She also exercises the dogs who are boarding there, and this is something she really enjoys. Helen communicates with her line manager, Louise, to ask which dogs need walking and in what order. She takes them walking all around the exercise field either on or off lead and then gives them a treat when she has safely taken them back inside their kennel.

Louise is very supportive of Helen and explains "It is lovely to see Helen and Julie each week and the dogs look forward to their walks and treats. Helen and Julie are great to have here on the WorkTaste programme and I really enjoy working with them."

Helen told us "I love going to the kennels and I especially like taking the dogs walking and giving them a treat afterwards".

We would like to thank Louise for giving Helen the opportunity not only to gain practical work experience but also for offering her such a positive and supportive placement at Moss Head.

Ben Hayes – Gawsworth Community Hub



The Gawsworth Community Hub first opened in March 2011 and has proved to be a popular asset within the village. In October 2021 a café was added to the Hub. Since then, it has grown in popularity which is staffed mainly by volunteers.

Ben Hayes was offered a WorkTaste placement at Gawsworth Community Hub and attended a meet and greet session, where he met manager Janet Keates, he started his placement a week later on 30th November 2022. Ben is now in his thirteenth week at The Hub and Janet is very pleased with Ben's progress. She said "Ben has settled in well, is punctual, always dressed appropriately and is liked by customers and staff. He copes very well with the variety of tasks in the café and shop which include placing stock in the outside store, emptying the dishwasher, clearing and wiping tables and packing sweets". Ben takes everything in his stride and copes well when the café is busy.

When putting stock away in the outside store Ben checks the dates and does stock rotation. He is very particular and places items with their labels facing the correct way. The use of Makaton and picture cards by myself and Janet has been a big help in communicating with Ben.

It is a pleasure to work with Ben. He is happy with his placement and is keen to continue.

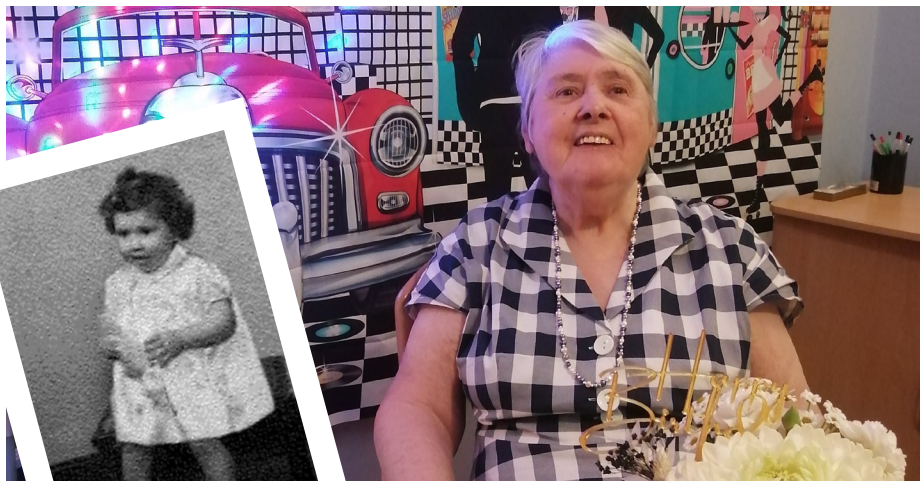


Congrats' Marlene

Our first fundraising event hosted by Emily Wilson at la Dulce Vendima, Church Street, Macclesfield was a great success. The intimate atmosphere created in this venue was enjoyed by eighteen guests. Emily took our palates on a journey through different countries, tasting a selection of white, red and rose wines - not normally available on the high street. Accompanied by a tasty platter of cheese and meats our guests were certainly interested in coming again. Thank you to everyone who came - we raised £550 including proceeds from a raffle. Thank You.

Oakwood - updates



Oakwood Manager Jason Blythe caught up with Paul McCandless who has recently partnered with the Trust in a project to grow more trees for the local area.

Hi Paul, what is it that you are doing at the Trust?"

Paul "We are growing trees from seeds we've collected in the local area. We are trying to combat climate change and benefit wildlife. The Trust's back garden is one of our main growing sites. We have 4 others and a number of people growing trees in their own back gardens."

What happens to the trees once they have grown?"

"Most will go out to local rewilding projects when they reach about 2ft tall. We are also growing some to be planted in more urban areas like streets, parks and gardens. These tend to be smaller, prettier and non-native. These will be grown for several years until they reach 6ft plus. We've been growing trees for about a year now and we have around 300 ready to go out this planting season.

They were all snapped up straight away though. It is clear that there is quite a big demand. We have a map on our Facebook page actually, that marks where they've all ended up.

This time next year, we are hoping to have several thousand ready to go to forever homes. I suspect that there will be an increased demand from companies wanting to have trees planted to try and offset emissions, so, we need to crack on and get growing them. It's all dependent on volunteer numbers though. The more helpers we have, the more trees we can get in the ground. At the moment there are not many of us. Hopefully, people will read your article, turn off love island, put their gardening gloves on and come along and help save the planet."

What will the environmental impact be?"

"A fully grown oak tree for example might suck up 1 tonne of Co2 by its 40th birthday. It can provide food and shelter for a large number of insect and bird species, not to mention squirrels and mice. You've got a few oaks in your back yard. We collected and planted around 3 thousand acorns from them in November. By December they'd all been scoffed!! Hopefully, we can get a bit of funding to construct some mouse meshed growing frames for next time. If so, there's potential there for 3000 tonnes of C02 to be removed from the air around Macc in the coming years. That would just be from 1 year's crop of Rossendale acorns - assuming all the trees were

planted in the right places and made it to 40. Just a few acorns and a bit of volunteer power could really make a difference I think. Obviously, the mice wouldn't be happy."

Oakwood in tune

Oakwood has recently started a new activity, Musical Theatre. In the musical theatre sessions, the groups sing, dance and act their way through famous musicals such as Grease, The Greatest Showman and Joseph. At each session, the group play drama games, learn scripts from famous scenes and get active with a dance routine. There are also lots of opportunities to perform to the rest of the group!

Sarah, our session lead said "The musical theatre session is a fusion of acting singing and dancing, the activity formed from a natural development of the drama session we were already running. The group loved to sing, dance and act to musicals so as a group, we decided to split the two and have a session based purely on that, it's been great that the group have led the direction of the activity."

Stacey, who has been attending the sessions said "It's top dollar, top of the world, everyone has got great voices and we all get on so well".

Adam, another member of the group said "I like that there are more and more people in the group and everyone is really nice".

Charlotte onboard



Charlotte Rayner recently passed her care worker apprenticeship and has taken on a permanent role at the Trust with Oakwood, whilst also working on the Supported Living side as bank staff.

Charlotte was nominated for Care Worker Apprentice of the year by her tutor from Macclesfield College and attended an awards night at the College. We are delighted to say that Charlotte won the award. We are all very proud of Charlotte and look forward to working with her to progress her career even further!
