#### A BIG move for Aidan

Aidan's family started the process of looking for supported living at the Trust in 2016 when Aidan was just 17. It was then that Aidan went on to our register of interest.

Each time a suitable vacancy became available we contacted Aidan's mum to let her know, but it has only been in the last year or so that the family were ready to start the process for Aidan to move.

During this time we have worked very closely with Aidan and his family to make sure that everyone involved has understood and was happy with the steps being taken to ensure a smooth transition into Supported Living. The whole process is person centered.

During the last year, Aidan's family have been able to visit the property, the local authority have approved the care package, Aidan himself came to visit and then was given time to think about the move and discuss it with his family until he was ready to sign his tenancy. Aidan also spent time getting to know the tenants and the staff and he even came along to our fashion show with his friends.

Aidan is happy with his new home, but taking the transition at his own pace and staying there currently as much as he is happy to. He'll continue to do this until he is ready to leave his family home (and cat) fully. We will support him along the way until he feels fully prepared to move permanently into his new home.

The Oakwood Music group have been ramping up their preparations for this year's annual performance of Shrek the Musical. With just two weeks of rehearsals left Jason Blythe, Day Service Manager caught up with the group to find out more about the show.

Trish, Oakwood Music Activity Leader has been practicing with the group twice a week since January. As she explains "It takes a lot of work, preparation, repetition and dedication from all involved to get to this point. We have to plan scripts, choose which songs to sing, decide which members of the group want to play which role, organise costumes, seating plans and props and liaise with the Oakwood Arts and Crafts group for their creative skills. There are challenges along the way, such as members changing groups when the four month timetable runs change, members being unable to attend certain weeks and repeating the same sessions to instil the words in the cast. Beckie, our music teacher does a brilliant job creating the scripts and song lists and so far, it's coming along very smoothly, fingers crossed for the big night!"

Jason also spoke to some members of the cast:

Christine "I've done lots of practicing, for the first time in all the years I've been doing the performances, I've even been practicing at home. It's been good, learning all the different words has been hard, I've enjoyed learning new songs I haven't heard before, my favourite is called Morning Person".
